21. General Architectural Description:

Two-story rectangular brick commercial building with flat roof with decorative cornice with two bands of brick corbels, band of rock-face stone, and rounded stone coping. Façade is divided into four bays by columns and pilasters. Upper story has pilasters composed of brick with stone bands that extend from decorative course of dentil brickwork at bottom of second story to roofline. Each bay of upper story has two tall, paired, narrow, segmental arched windows with stone hood molds and shared stone sills. The windows have been shortened with brick infill and have short sliding windows. First story is divided by metal columns into four storefronts corresponding to the bays of the

upper story. Above storefronts is continuous metal lintel with floral ornaments. The clerestories below the lintel are covered up on each storefront except for the southernmost. The storefronts have inset glazed doors with transoms and sidelights, plate glass display windows, and brown brick below the windows. The Merry Christmas store (117?) is slightly different, with a paneled and glazed door with leaded glazing and paneled and glazed sidelights, tall fixed light windows flanking entrance, and a two-light clerestory. At the south end of the building is an inset pedestrian door with metal frame glazed door and transom.

29. Construction History (include description and dates of major additions, alterations, or demolitions): The footprint of the building remained unchanged on Sanborn maps of 1893-1945. The 1981 survey form noted that the building was undergoing rehabilitation after a fire. The windows of the second story had already been modified, and the first story appeared much as it does today.

35. Historical Background:

Sanborn maps indicate that this building was erected between 1890 and 1893, and was known as the Sweet Block during its early years. The original owner of the building has not been identified. Eleanor Fry reports that Sweet & Co., grain dealers, was one of Salida's first businesses. In 1893, the building contained an office (109), two vacant spaces (111-13), and a newsstand. By 1898 the building housed a barber (109), a dry goods and clothing store (111-13) and a newsstand (115). The 1903-04 city directory indicates that John M. Manful had a barbershop here (109). Manful was the leader of the Manful Orchestra and the Scenic Line Band (an organization of nonprofessionals which won third prize at a national contest), and was also listed at this address in the 1905-06 and 1909 city directories. His was called the largest and best appointed barber shop and bath rooms in the city. The firm included four barber chairs, attended bath rooms, and a shine chair. Adolph Unger operated a clothing and men's furnishing store here (111-113) in 1903-04. He advertised himself as "the one-priced clothier" and "the store that stands between you and high prices." Unger's business was replaced by the Crystal Bakery operated by Phil Gessert in 1907. Newell W. Meigs had a book and stationery store in 115 F in 1903-04, that may have dated to the original opening of the building. By 1905-06 this space was occupied by The People's Store managed by Edward C. Berrian. Berrian offered books, stationery, novelties, souvenirs, school supplies, and baseball goods (he later specialized in real estate). The same business was listed in 1909. The upstairs of the building housed professional

offices during 1903-1909. Among the professionals with offices here during the 1900s were: Thomas J. Jones, Thomas N. Moxon (physician for the Ohio Smelting & Refining Co.), Taylor E. Julien (insurance and justice of the peace), and James H. Stead (justice of the peace).

The 1914 Sanborn showed the following businesses in the building: barber, shine, books, and vacant space. By the time of the 1922-23 city directory, a clothing company known as "The House of Murdock" or "Murdock's" operated here. The 1927 "Booster Edition" of the "Salida Mail" called Murdock's the "big men's furnishing goods store of Salida." Sam Murdock was proprietor of the business, which dated to 1899. Murdock moved to Salida about 1897, and had continuously been in men's furnishings since that time, rising from clerk to partner to operator of his own business. "Mr. Murdock's heart and purse are with every forward movement in Salida. His store is a credit to the city because it is as fine in appearance as well in quality of merchandise as can be found in the state." Murdock also co-managed the Disman Clothing Co. with Ben Graf beginning in 1909.

The 1927-28 and 1930-31 city directories indicated that this building housed Murdock's (113-115) and John Manful's barber shop, which had been operating in the same space since at least the early 1900s. In 1949, Murdock's was sold to C.F. Hobson of Greeley and K.M. Hyde of Eaton. By 1951, these businesses were gone. Manful's barber shop was replaced by Sharpe's Ladies Ready to Wear (L.H. & Edith Sharpe, owners). Sharpe's had offered "latest styles in ladies' ready-to-wear" since 1948. Andon's Eatwell Café (James Andon, owner), was also operating here in 1951. Apartments were listed in the upstairs rooms. In the 1960s and 1970s this building housed Salida Drug. The 1981 survey showed The Closet at this address.

This building is associated with the development of downtown Salida in the 1890s, and housed several longtime businesses, including a barber shop, a book and stationery store, and clothing stores. Alterations to the building have affected its historic physical integrity somewhat, although it retains its brick and stone pilasters, metal columns, original storefront divisions, and decorative brickwork.

43. Assessment of Historic Physical Integrity Related to Significance:

This building has undergone moderate alterations, most notably the bricking of the second story windows and the addition of short nonhistoric windows. The first story storefronts have undergone some alterations, including covering of the clerestory areas and nonhistoric brick under the display windows.




