One-story painted brick commercial building with flat roof with corbelled brick cornice. Metal sign structure on roof and sign projecting at north end of façade for drive-up window. Painted sign beneath cornice. Projecting, hipped roof wood shingled hood shelters storefront. Slightly off-center entrance with wood door with large rectangular light and covered transom. Angled walls leading to entrance. Metal frame plate glass display windows with paneled brick kickplates. East wall is stuccoed and has drive-up window sheltered by shingled hood and chimney with metal pipe top. Projecting stuccoed wing on rear with projecting off-center garage entrance. Remodeling in the fall of

2002 removed the shingled hood, revealing clerestory windows.

29. Construction History (include description and dates of major additions, alterations, or demolitions):

The 1898 Sanborn map shows that this block was vacant. This building appears on the 1904 map, with a narrow rectangular saloon building at the front end, a wider rectangular bay at the center, and a rectangular bay projecting to the rear with beveled corners. Between 1909 and 1914 the size of the saloon bay at the front of the building was doubled in width. Between 1914 and 1929 an addition was built on the south side of the rear bay. The drive-in window was added in 1971. The façade today has the same appearance that it did at the time of the 1981 survey. After the current photograph was taken, the façade was remodeled in the fall of 2002.

35. Historical Background:

This building was erected between 1898 and 1904. The 1898 Sanborn map shows the entire block was vacant. The present building appears on the 1904 map, when it included a saloon at the front and a gambling operation in the middle and rear bays. The 1903-04 city directory indicates that this was the saloon of Frank A. Windiate, as does the 1905-06 directory. The 1 January 1904 edition of the Salida Record discusses the Gem Saloon, owned and operated by Frank A. Windiate. "The place is beautifully appointed, conveniently located and properly conducted, the three things most requisite to the successful saloon. Mr. Windiate knows how to treat his customers and knows how to maintain the class of trade that is most desirable. His splendidly appointed saloon and club rooms attract the most particular customers, who want the best that is to be bought...All thirsty wayfarers who come to Salida have long since learned to look for his sign." A photograph of the interior of the saloon was also included in the article. The 1909 city directory listed Windiate's saloon at this location. The 1914 Sanborn map showed a saloon in the front of the building and gambling at the rear.

Prohibition resulted in the end of the saloon in 1918. The 1929 Sanborn map indicated that the front part was a store, while "gambling" was still shown at the rear. The Park Café, operated by I.M. Taliaferro and H.W. Mueller, was located here according to the 1927-28 city directory, while the 1930-31 city directory indicated that the Park Café was still here, but operated by Lawrence and I.M. Taliaferro. The 1945 Sanborn map indicated that a store

was in the front part of the building; the rear part was no longer labeled "gambling." In 1951, this was the location of the Dinkins Liquor Store, operated by Roy Dinkins. In 1961, the Park Liquor Store, managed by Edward Greasart was operating here. A 1971 article in the Pueblo Chieftain reported that the Jug liquor store was operated here by Irvin Oberle and owned by Louis Argys. The business was described as "a curious blend of old and new. Iron hitch rings, relics from horse and buggy days, are still imbedded in the curb and an unusual collection of crockery liquor jugs attracts attention in the front window, while a drive-in window, the first in Salida, is nearly completed."

This building is associated with the development of North F Street at the turn of the century, and has housed liquor stores for much of its history. An interesting feature of the building's history is the rear gambling hall that operated for many years. The building's façade is somewhat altered, but it retains its corbelled brick cornice and recessed entrance, as well as its rear gambling hall.

This building has undergone a variety of alterations, but retains its corbelled brick cornice, inset entrance, and rear gambling hall.


