## Dear Sir:

Having knowledge of your far-famed philanthropy, and knowing the great good that has come to some communnities of our acquaintance through your beneficence in founding libraries, the Library Association of Salida, Colorado, which is also the Tuesday Evening Club, an organization of women, begs leave through me, their president-elect, to ask a place in your consideration, to the end that possibly you may find us worthy of your help in the establishment of a library for our little City.

I understand that a few years ago, the President of our Society addressed some letters to you on this subject and you answered favorably, but at that time our conditions were so incomplete that we could not proceed to anything definite. We wish to call your honorable attention to the library conditions of our place to-day, as follows:-

Our Library Association is a chartered organization. We own, free of debt, over two thousand volumes of books in good condition, in good cases or shelves. A small portion of these books is for reference, the others are for the purpose of loaning. A library ticket costs two dollars (\$2.00) per year. We have worked for eleven years with the intention of sometime making this into a free, public library to be deeded to pur City.

Salida was started as a little Denver and Rio Grande Railroad station twenty-five years ago. It has steadily grown to be a town of over five thousand inhabitants, the increase in population during the

last five years, being sover twelve hundred.

Railroad shops and Round Houses were soon established here and it became a division point, one line of road going via Leadville, the other via Marshall Pass. Salida, meaning "Open View", is the only natural opening into the great San Luis Valley and adjacent mining camps. Our population is composed, by about two-thirds, of Railroad families, who mostly own their little homes. There is a large , independent smelter one and one-half miles out of town, which, while not included in the corporation, has a community of people employed that could receive the benefit of a free public library in Salida. There are between threehundred and four-hundred people in this smelter suburb, and many of the families own their homes.

The enrollment of school children the last year in Salida was somewhat over nine hundred.

The following facts, I have recently received from our County Assessor:

The property valuation of Salida for 1904 was seven hundred and eighty three thousand, one hundred and nine dollars (\$783,109.00) which is only about 33 1/3 % of the real valuation. The estimated increase for 1905 is \$100,000.00, caused by **new property** and an increase of valuation on lots.

Agriculture and stock-raising have been carried on in this region for over forty years and both are still usuccessful.

Our Library Association has a fund started for purchasing a lot on which to build a library. This work we intend to puch industriously until completed.

As to securing an income from a City tax, we feel much encouraged. We have an intelligent, moral and progressive Mayor, together with sevearl Aldermen of the same kind, elected for a term of two years. These gentlemen, we have good reason to believe, are favorable to our project of establishing a library.

If we could have some assurance that you still look upon our situation favorably as a point where your efforts and your generosity might be expended, we believe the impetus for securing the fund for a building site would be doubled.

And if we are lacking any other conditions for securing your favor than these of a site and the guarantee of the tax income, will you be pleased to so inform us? Then will it be to our greatest interest and pleasure to work along the lines you may dictate.

My Dear Sir:-

Our expenses were greater before the Town Council allowed us to move into their head quarters, whrer we have no rent to pay, but the circulation of our books has fallen off, as it is embarrassing to some patrons to appear in a room where the police magistrate is holding his court.

As implied in my letter of July 17th, we have spent most of the money we have collected from membership fees and dues and from entertainments in buying books and good bookcases.

We have a small fund started and some prospect of getting a thousand dollars toward the site from one of our citizens; but if that plan does not materialize, we are thinking of calling a mass meeting for the purpose of raising the sum, \$1500.00necessary to purchase the lot or two lots on which we hope to get an Option.

It is the intention of the Tuesday Evening Club, which owns the books and cases and is chartered as The Salida Library Association, to deed the site that may be purchased to the town of Salida as soon as we can have the building assured on such condition.
